

Aberdeen Local Development Plan Proposed Plan Response Form

The City Council is preparing a new Aberdeen Local Development Plan which we hope to adopt in 2012. The Plan will show which land is being allocated to meet the city's development needs and it will set out the planning policies to be applied in promoting sustainable growth.

A Proposed Plan has now been prepared which contains the Council's firm view on which sites, policies and proposals should be included in the adopted Plan. Additional details are found in Supplementary Guidance.

You now have an opportunity to submit to us representations about the Proposed Plan. A separate form is available for commenting on Supplementary Guidance. Planning guidance advises that comments on the Proposed Plan should be concise, generally no more than 2,000 words plus limited supporting documents.

You should fully explain the issues you wish to have considered as there is unlikely to be an opportunity to expand on these comments at a later stage. Unresolved objections will be forwarded for examination by a person appointed by Scottish Ministers. That person will decide whether to ask for more information from respondents before making a decision on whether or not the Plan should be changed.
