# Supplementary Guidance Response Form


The City Council is preparing a new Aberdeen Local Development Plan which we hope to adopt in 2012. The Plan will show which land is being allocated to meet the city's development needs and it will set out the planning policies to be applied in promoting sustainable growth.

A Proposed Plan has now been prepared which contains the Council's firm view on which sites, policies and proposals should be included in the adopted Plan. Additional details are found in Supplementary Guidance.

We will consider your comments before we finalise our Guidance and send it to Scottish Ministers. We must also send the Ministers a statement setting out the publicity measures we have taken and the comments we have received. We also have to explain how these comments have been taken into account.
